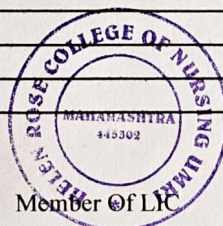

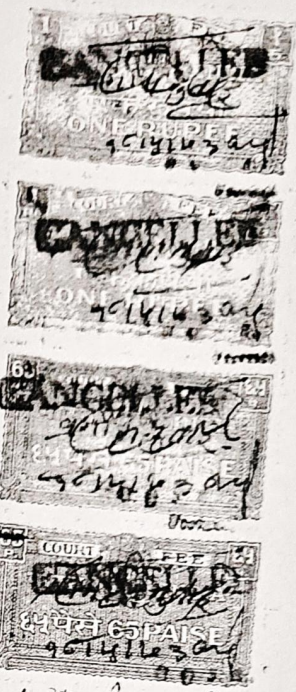

DEED OF TRANSFER OF TRUST PROPERTY FROM ONE TRUST TO ANOTHER TRUST

THIS DEED OF TRANSFER from One Trustee to another Trustee made
this 14th day of April One thousand nine hundred and seventy-three.

WHEREAS, the General Missionary Board of the Free Methodist Church incorporated on the 19th day June, 1885 in the State of Illinois U. S. A., having been formed to "collect, receive, hold, expend, pay out and dispose of any property real or personal or of whatever nature and wherever situate as allowed by law that may be given, obtained, or held in aid of the General Missionary work of the Free Methodist Church" the name of which General Missionary Board was subsequently changed on January 3rd, 1895 by adding the words, "North America," making it to read "General Missionary Board of the Free Methodist Church of North America" and whose object was enlarged "to acquire by purchase, give or devise real estate and personal property in the United States of North America or in foreign lands and to hold or to sell or convey the same as may in its judgment be necessary or helpful in the prosecution of its missionary work."

AND the Articles of Incorporation were further amended on the 7th January 1967 confirming that the property of the said Missionary Board stood irrevocably dedicated to Charitable and Religious purposes.

And the said General Missionary Board of the Free Methodist Church of North America shall be herein referred to as the "Transferor - Trustees" (which expression shall include their predecessors in interest, successors in interest and assigns) of the first part represented herein by the duly appointed Power of Attorney, E. Eugene Stewart;

AND WHEREAS the EVANGELICAL TRUST ASSOCIATION OF NORTH INDIA, a Company incorporated under the Companies Act (Act) of 1956) having its registered office at New Delhi, one of its objects being to accept properties to be held:

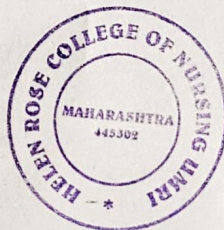
- a) Upon trust for the general objects of the Association.
- b) Upon special trust for any of the objects mentioned in the memorandum to be declared by the donor
- c) Upon special trust already in existence for any of such objects in case, where a corporation may lawfully be a trustee thereof.
- d) As the bare depository of the legal or other ownership of property devoted to any of the objects mentioned in the Memorandum, special trust of which is to be carried out and administered by another body of trustees and the said Company shall be hereinafter referred to as the "Transferee - Trustees" (which expression shall include the successors in interest and assigns) of the second part represented herein by the duly appointed Power of Attorney.

WHEREAS the immovable properties more particularly described in Part I of the Schedule attached hereunto are vested in the Transferor Trustees upon Trust for the General Missionary Board of the Free Methodist Church of North America for the purposes more briefly described in Part II of the said Schedule;

AND WHEREAS it has been agreed that the Transferor Trustees should transfer to the Transferee Trustees all the said immovable properties described in Part I of the Schedule to be held by the Transferee Trustees upon the same Trusts..

NOW THIS DEED WITNESSETH that the Transferor Trustees do hereby transfer convey and assign unto the Transferee Trustees all and singular the immovable property more particularly described in Part I of the Schedule hereto TO HOLD the same according to the tenures on which they are now held by the Transferor Trustees with power to sell or lease the said immovable property or any part thereof and to apply the proceeds of sale or rent and /or premium for the purpose aforesaid.

AND THIS DEED ALSO WITNESSES that in consideration of the premises the Transferee Trustees hereby covenant with the Transferor Trustee that the Transferee Trustee will at all times use and occupy the properties hereby conveyed and each of them and every part thereof for the purposes to which the same are respectively dedicated and will in all things carry out and observe the respective trusts applicable to them and each and every one of them respectively and will not divert such properties or any of them or any part thereof from the purposes for which the same should be occupied and employed under the Trusts specifically relating thereto AND will at all times save harmless and keep the Transferor Trustees and their successors and assigns effectively indemnified against all claims and demands, actions and proceedings on the part of any person or persons or body interested in the said properties or any of them or any person or persons whomsoever and all costs, charges, and expenses in respect thereof or in any way arising out of or consequential upon the occupation or use of the said properties or any of them.

PART II

Objectives And Purposes For Which The Above Property is Placed in Trust.

1) The property of the Umri Mission Hospital and Yardy Memorial T. B. Sanitorium shall be held in trust for the purposes outlined in Article III of the Constitution of Umri Mission Hospital which are as follows;

- a) In the spirit of Jesus Christ, the Great Physician, to treat and care for the sick without distinction as to caste, creed or colour and to acquaint others with his Person as opportunity permits.
- b) To promote the knowledge of health with a view to the prevention of disease.
- c) To serve the poor in such way as resources permit
- d) To maintain the highest possible professional standards at all times
- e) To make the Hospital an integral part of the programme of the Church in the area that it serves.

The Hospital and T. B Sanitorium property shall be administered under the controlling bodies as described in Articles IV and V of the Constitution of Umri Mission Hospital as such Articles shall be amended from time to time In the event the above bodies should be unable to continue such administration, the Hospital shall be turned over to the India Free Methodist Church or some other body which is able to fulfill the purposes stated above

2) The property of the Umri Christian Elementary and Middle School shall be used solely for educational purpose and not for purposes of profit, and shall be managed by the Board of Governors elected for that purpose. In the event the above body is unable to continue such management the property shall be managed by the India Free Methodist Church or a body approved by them which can carry out the purposes above.

3) The property listed under 5 and 6 above, namely that at Chikhaldia and Kodaikanal, shall be used as rest and retreat areas for Free Methodist missionaries and others It may also be used for benevolent, religious or educational purposes on behalf of the India Free Methodist Mission. In the event any part or all of the property is sold, the proceeds shall be used for the benevolent, religious, charitable or educational works of the India Free Methodist Mission, the India Free Methodist Church, the Umri Mission Hospital or the Union Biblical Seminary in Yeotmal provided the last named institution continues to operate in Yeotmal, Maharashtra The Evangelical Trust Association of North India will respect the wishes of the Transferor Trustees regarding the distribution of the proceeds in the event of sale or other disposal of the Trust properties.

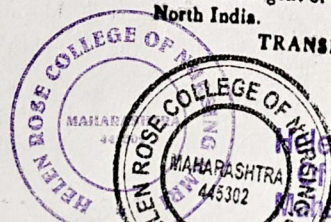

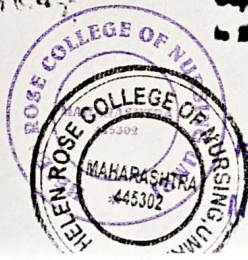



This letter is to certify as under.

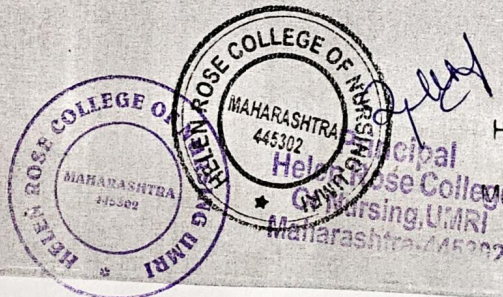

17. You shall submit the bank guarantee of INR 2.50 lakhs towards compliance of conditions as specified in Schedule III to The Regional Officer, MPCB, Chandrapur within 15 days. Non submission of B.G. in specified time shall attract 12% interest on B.G. amount.

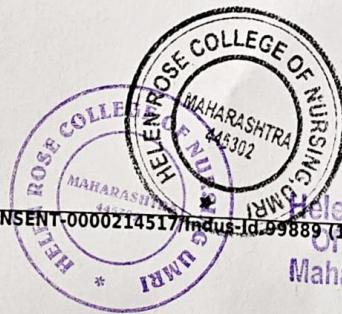
